

Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form. You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an

authorisation form allowing your vehicle to enter the exhibition grounds, along with the gate through which you should enter.

Please note: In case of high volume of traffic waiting times are possible at the Check-In! All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense. back

Car parking spaces

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t and for car trailers. Please use the Shop for Exhibitor Services (www.serviceshop.messe-frankfurt.com) to make your reservations by no later than four weeks before the start of the event. It may not be possible to honour orders made after this time.

Truck parking spaces

You may park your vehicle for set-up/dismantling at the Rebstock E1 truck park for a fee for general dismantling activities. Reservations are not required.

Parking permits will not be sent by e-mail until the ordering deadline has passed.

Set-up

Advanced set-up 31 October + 1 November

Please note that it is not possible to <u>register</u> vehicles until confirmation for advance set-up has been received.

Advanced set-up must be ordered from the Shop for Exhibitor Services (<u>www.serviceshop.messefrankfurt.com</u>). back

Trade fair

Deliveries during trade fair 7 – 10 November

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit.

Last day of the trade fair 10 November

- Entry will not be permitted after 2 p.m.
- From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the E1 assembly point at the Rebstock car park. This
 is the only place where you can obtain a dismantling vehicle pass.

Set-up 2 – 6 November Registration required

Set-up ends 6 November 2023 by 6 p.m.

Please note that the aisles must be clear from 6 p.m. on 6 November. After that, set-up is only possible within the stands. back

Entrance for vehicles up to 3.5t 10 November, 4 p.m. – 6 p.m.

Exhibitors wishing to transport smaller loads by cars and vans up to 3.5 t gross vehicle weight rating can access the halls from the car park or the Rebstock Block D assembly point via Gate West.

The vehicle must be returned to the car park or leave the exhibition grounds by 6 p.m. at the latest. Otherwise the vehicle will be towed away for a fee.

Please note that you will not be able to use the goods lifts.

Dismantling

General admission for dismantling vehicles 10 November after 7:00 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 7:00 p.m.

Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.
